The camp is designed to be low-key, with an emphasis on fundamentals and basic techniques. Except for the individualized swimming program, each boy will be able to choose, for the standard camp fee, the program or programs he is interested in. His program will be conducted by a coach who is interested not only in athletics but also personal improvement. The "total athlete" is one who strives to meet his potential as a person.

There are four one-week sessions to choose from. You may select any or all of these sessions. The price per week is \$80.00, plus a ONE-TIME \$4.00 fee per student for summer insurance.

This year, we are again going to offer individualized swimming instruction. This program is optional and, as it requires special instructors, will cost an additional \$20.00 per week. This program will be for beginning, intermediate, and advanced swimmers, and will require special instruction each day. If you are interested in any of these courses, please check the appropriate box on the registration form.

The camp will be offered the following weeks:

June 22-26 July 6-10 July 13-17 July 20-24

Each day begins at 9:00 AM and ends at 1:00 PM. Transportation to and from Servite will be the responsibility of the participants. There will be a short snack period during which time students can either purchase snacks or eat items brought from home.
